Mayor Ken Williams moved to approve the Liquor License for Ogle County Brewery LLC, Seconded by Commissioner Melanie Cozzi.

Discussion: Mayor Ken Williams said that Ogle County Brewery, LLC will be a microbrewery located at the corner of Rt. 2 and Rt. 64. They need to receive the local liquor license before moving forward to the State License. They are hoping to open in October.

Roll Call: Cozzi, Krug, Schuster, Wilson, Williams. No Nays.

Commissioner Terry Schuster moved to approve the CMAAA Job Description for the City, Seconded by Commissioner Kurt Wilson.

Discussion: City Administrator Darin DeHaan said the CMAAA director's role for the City would include promoting and collaborating with other community groups as well as other taxing bodies. Commissioner Terry Schuster said that the City is proud of the creative culture in our community. Enhancing this culture would be a part of the director's responsibilities for the City.

Roll Call: Cozzi, Krug, Schuster, Wilson, Williams. No Nays.

Commissioner Tim Krug moved to approve Resolution 2020-14 Temporarily Close River Road for Fire Works, Seconded by Commissioner Melanie Cozzi.

Discussion: Chief Shawn Melville plans on having extra officers to redirect traffic during the 30-minute display. People will be able to view the fireworks from the East and West side of River Road. Commissioner Terry Schuster asked about social distancing during the event. The Health Department may step in with social distancing guidelines. Commissioner Melanie Cozzi asked if the Park District chose this location and if the 1-year term of coverage was typical. City Administrator Darin DeHaan said that the 1-year coverage is typical. Chief Shawn Melville will be meeting with the Oregon Park District on August 3rd or 4th to discuss plans for the event and any further questions can be directed to him.

Subcommittee for Mosquito Abatement Recommendation was tabled.

Commissioner Kurt Wilson said that Moring Disposal's report for recycling counts could be inaccurate. He has contacted them to see if there was a mistake.

Commissioner Terry Schuster said that he has been reviewing the budget projections for fiscal year 2021 to see if they are low or high. He estimates that the City is around 9% over what is budgeted for this fiscal year. He also stated that the City currently has an A+ rating with S & P Global, a financial information and analytics company.

Commissioner Melanie Cozzi asked Water Sewer Superintendent Dave Kent to provide an update on recent projects. Dave Kent said that Martin and Company are working on 10th street with the watermain replacement project. He also said that there was a pre-construction meeting for the 5th street parking lot project this morning.

Commissioner Tim Krug reported that the Paul Shaffner project has begun with a completion day within 60-90 days.

Mayor Ken Williams said that he has a conference call with S & P Global to go over the draft of the annual report bond rating. He also stated that the first Friday of the month is Coffee with the Mayor at 9:00 am.

Commissioner Kurt Wilson moved to adjourn the meeting, Seconded by Commissioner Terry Schuster.
