City Administrator Darin DeHaan met with Tom Champley to discuss options for the feral cat colonies in town. They discussed a trap neuter return program through HOME Spay Illinois, a program located in Lisle IL. Dr. Champley offered to volunteer his time to perform the spay/neuter of the feral cats, but the city would need to provide a surgery/recovery location to house the cats until they are ready to be released. A surgical table and an anesthesia machine would need to be purchased. The city could also partner with Pines Meadow Vet Clinic. The cats would still need to be housed by the city as they will not allow the cats to remain on site after the surgery. The city would provide seed money to get the program started. The program would have to be run be a group of volunteers and they would have to apply for grants or find other sources of revenue to continue to fund the program. A formal program may be ready by the next City Council meeting.

City Administrator Darin DeHaan is working on getting the donated railcar to the property the city has leased from BNSF. The Depot Museum is also going to start a live feed of the railway activity. There will be a new bid for the ADA compliant ramp at the Coliseum. The fire department has also accepted the easement agreements for the river walk.

Commissioner Kurt Wilson has been working with Chief Shawn Melville to help get some properties in town cleaned up. Mayor Ken Williams would like to see the downtown snow program ready before we have bad weather. Darin DeHaan stated he is working with the Street Superintendent on snow removal for the city owned properties. More contractors are needed to handle the city properties, so they are completed in accordance with the ordinance.

City Attorney Paul Chadwick will be responding to a request from the Building Inspector.

Commissioner Tim Krug reported the street department had over 80 hours of storm damage to clean up. They are starting on some sidewalk repair projects and have trimmed the AOP Parade Route. The new parking signs have also been installed in the parking lots.

Commissioner Melanie Cozzi said the water is being tested for the watermain work on Jefferson Street from 8th Street to 10th Street. She also stated there are only 3 more farmer's markets scheduled for this year.

Mayor Ken Williams said the downtown looks amazing and he sees the benches by Iron Mike being used.

Commissioner Kurt Wilson moved to go into Executive Session to discuss personnel at 6:09 pm, Seconded by Commissioner Tim Krug.
