Discussion: Sjostrom and Sons, Inc. were awarded the ADA Ramp project with a bid of \$135,700.00. They will be working over the winter to complete the project possibly by Christmas.

Commissioner Terry Schuster moved to approve the Budget Adjustment of \$13,540.00 for the 5th Street Municipal Parking Lot Project, Seconded by Commissioner Tim Krug.

Discussion: Areas of the parking lot are severely damaged and if not properly addressed now could potentially cause the material to fail. O'Brien Civil Works suggested digging deeper before resurfacing the parking areas.

Mayor Ken Williams stated a pre-application has been submitted to FEMA for a mitigation grant involving Lake Mistake and the Gale Creek Drain. He also stated that Chris Manheim and Darin DeHaan submitted a tourism grant this week.
