Mayor Ken Williams moved to approve updating the Job Descriptions for the Police Department, Seconded by Commissioner Tim Krug.

Discussion: The updates include changes to experience and training requirements for the Police Sergeant and Lieutenant position.

Roll Call: Cozzi, Krug, Schuster, Wilson, Williams. No Nays.

The City Council discussed Tourist Homes/Short Term Rentals Ordinance 2022-102 that included the length of stay, application and renewal fees, and participation in certifications, safety requirements, and applicable state tax laws.

The City Council discussed amending the Oregon City Code Chapter 34.2 Fee Schedule regarding video game terminals. A change in state law allows for a municipality to charge 250 dollars per video game terminal. The fees for the terminals are shared equally between the video gaming operator and the gaming institution.

An intergovernmental agreement with the Oregon Park District regarding the bridge sidewalk was discussed. This agreement would clearly define the responsibilities of the City of Oregon and the Oregon Park District when it comes to maintenance, repair, and snow removal of the sidewalk along the Rt. 64 bridge.

An intergovernmental agreement with the Oregon School District regarding the School Resource Officer was also discussed. The school district asked for language to be added to the agreement in accordance with the Safety Act, which would allow the SRO to wear a body camera within the school district. The school also agreed to a longer contract since the SRO position requires specialized training and skills.

City Administrator Darin DeHaan said CMAAA is moving forward, and their vision is coming to fruition. The weather has kept the rails for the ramp from being installed.

Commissioner Kurt Wilson said building permits are coming in more frequently.

Commissioner Terry Schuster said he is working on the third quarter fund reviews. He also stated that State of Illinois revenues are higher than expected.

City Attorney Paul Chadwick and City Administrator Darin DeHaan are collaborating on a few projects.

Jeff Pennington thanked City Administrator Darin DeHaan for putting pictures in his report for the work the water/wastewater department is working on for the new housing development on S. 2nd Street.
