Commissioner Kurt Wilson moved to approve a Special Use for a Short-Term Rental submitted by Maryann Mahan for the property located at 606 Timberlane Parcel #16-03-103-004, Seconded by Commissioner Tim Krug.

Discussion: The owner will be using two rooms and a bathroom on the second floor of her home as an Air B&B. She will still occupy the downstairs.

Roll Call: Cozzi, Krug, Schuster, Wilson, Williams. No Nays.

Commissioner Tim Krug moved to approve Maintenance Engineering to be Performed by Willett Hofmann and Associates, Seconded by Commissioner Melanie Cozzi.

Discussion: Willett Hofmann and Associates will be the consulting engineer for the upcoming seal coat project. The estimate for the seal coating is \$170,430.65.

Roll Call: Cozzi, Krug, Schuster, Wilson, Williams. No Nays.

Commissioner Tim Krug moved to approve Resolution 2022-2 Motor Fuel Tax Maintenance for Streets, Seconded by Commissioner Kurt Wilson.

Discussion: The seal coating project includes the East side of Oregon and Oregon Trail Road. Oregon Trail Road will have multiple layers to help build up the surface of the road. A resolution is required when the city uses motor fuel tax funds for road projects. A map of the streets that will be seal coated is available to residents on the city website.

Roll Call: Cozzi, Krug, Schuster, Wilson, Williams. No Nays.

A first reading of the non-highway vehicle ordinance was discussed. The ordinance applies only to the City of Oregon jurisdiction. There would be no connectivity between other communities due to state law requirements. The proposed ordinance has been approved by the Planning Commission and is only a starting point to get Council member and public feedback. The ordinance is available to be read by the public.

City Administrator Darin DeHaan is starting to prepare the city newsletter and will be reaching out to department heads for content.

Commissioner Terry Schuster asked if there have been any comments on the city manager form of government. Roger Cain will be meeting with different groups within the community.

Commissioner Tim Krug said the street department has cleaned 127 catch basins. They will also start street sweeping and sidewalk maintenance soon.

Mayor Ken Williams said Chief Shawn Melville, SRO Matt Kalnins, and City Administrator Darin DeHaan attended a Mental Health training program. Plans for additional parking on 1st Street have also been submitted to the city by Willett Hofmann and Associates.

Commissioner Kurt Wilson moved to adjourn the meeting, Seconded by Commissioner Melanie Cozzi.
