APPLICATION FOR ANNUAL PERMIT
NON-HIGHWAY VEHICLE

Pursuant to Title 24, Chapter 26 of the Oregon City Code, certain non-highway vehicles may be approved for use on specified streets, roadways, and alleys of the City of Oregon where the posted speed limit is 35 miles per hours or less. Non-highway vehicles may not be used on any toll road, interstate highway, controlled access highway, or other highway or road under the jurisdiction of the State of Illinois. At present "non-highway vehicles" include only those vehicles defined under law as "recreational off-highway vehicles." "Recreational off-highway vehicles" means any motorized off-highway device designed to travel primarily off-highway, 64 inches or less in width, having manufacturer's dry weight of 2,000 pounds or less, traveling on 4 or more non-highway tires, designed with a non-straddle seat and a steering wheel for steering control, except equipment such as lawnmowers. Applicants shall be required to comply with all respects of Title 24, Chapter 26 of the Oregon City Code, and the Illinois Vehicle Code, including the obligation to purchase an annual permit. Violations may result in the suspension or revocation of the permit and significant fines and other penalties.
