Commissioner Tim Krug moved to approve Ordinance 2022-104 Establishing a Tree Board, Seconded by Commissioner Kurt Wilson.

Discussion: The ordinance is a requirement of the grant the city received. The Tree Board will work on replacing trees, tree preservation, approve trees for city terraces, and complete requirements for the city to become a Tree USA city.

Commissioner Terry Schuster moved to approve the Private Project TIF Request 1 for Reimbursement for Merlin & Cindy Hagemann, Seconded by Commissioner Tim Krug.

Discussion: The redevelopment agreement was previously approved. The city now has the paid project receipts to disburse the funds.

Commissioner Terry Schuster stated the city budget review will be postponed till the next council meeting.

Ordinance 2022-108 Litter did not transfer over when the code was updated. The proposed ordinance mirrors the state law and gives local law enforcement guidance for enforcement. The ordinance will be voted on at the next city council meeting.

Public Works Director Bill Covell said he is looking forward to help improve any city projects.

City Administrator Darin DeHaan said the ComEd lighting upgrades at the street garage and City Hall have been completed. There was a significant savings to the project as well as enhanced workspace.

Commissioner Melanie Cozzi stated the City Manager Committee has collected the petitions and the attorney has reviewed them. She thanked the committee for all the help. She also thanked Tyler Hagemann for the planter at the Farmers Market. The Bubble Guy, Oregon Public Library, and Marques Morel Music will be at the Farmers Market Thursday.

Commissioner Tim Krug welcomed Bill Covell. He also asked for patience from residents while O'Brien's complete sidewalk and street reconstruction on South 3rd Street.

Mayor Ken Williams said the Hotel Feasibility Study will be release to the City Council and the public. He also stated that the city has never had a formal replacement program for trees that have been removed and now we do.

Chief Shawn Melville congratulated Lieutenant Randy Cropp on his retirement after twenty-two and a half years. Lieutenant Cropp has served as Corporeal, Sergeant, Lieutenant, and SRO for the City of Oregon.
