The City Council reviewed Ordinance 2022-115, an Ordinance adopting chapter 20.03 regarding Tree Preservation Regulations. A requirement of the grant the city received from Morton Arboretum is the city create an ordinance adopting tree preservation. City Administrator Darin DeHaan thanked Street Superintendent Terry Plemmons for all his help with the ordinance. Residents have also expressed concerns and interests in the development of this ordinance. Fines and fees still need to be built into the ordinance. The ordinance will only be for trees located on terraces and public property. A second reading of the ordinance will be presented at the next City Council meeting.

Commissioner Kurt Wilson said there was a noise complaint from a resident regarding the dumpster by Dairy Queen. He is still waiting for a resolution from Moring Disposal.

Commissioner Terry Schuster said he is happy the annual appropriation and budget are completed and is looking forward to the audit report.

Commissioner Melanie Cozzi congratulated Dustin Runyon on obtaining his Class C water license.

Commissioner Tim Krug thanked the public works department for doing an excellent job on storm damage cleanup.

City Clerk Cheryl Hilton asked if the Council would consider a change in the meeting time or date for the August 9<sup>th</sup> meeting due to the City Administrator and two commissioners being out of town. The Council decided to change the time of the meeting to 6 PM.

Public Works Director Bill Covell said the public works department did an impressive job on storm damage cleanup.

Mayor Ken Williams thanked the public works department for working on Sunday to work on storm damage cleanup. He also thanked Commissioner Terry Schuster and staff for the work that went into putting the appropriations and budget together. He also stated the developer for the Trestle Ridge subdivision amended the previous grass paving emergency access road to fourteen foot wide which was requested previously by the City Council.
