I completed an IT assessment of the City with a potential vendor. I have received the security audit and will continue to implement policies accordingly.

Held a Retail lease subsidy review for a new retail business with a recommendation of approval for the Economic Development Committee.

Continue to work on a solar ordinance with the Planning Commission.

Attended a webinar from the Illinois Office of Broadband and Illinois Broadband.

Conducted the quarterly cyber training analysis for KnowBe4 training for staff. New training will be pushed out soon.

Met with Chief Knoup at the fire department to review some items that need to be addressed with the new recreation path. Bill will be ordering some signage as well as striping the path. We discussed a possible stage for the Farmer's Market that Council Member Cozzi is working on.

Completed the walk through of the old Dayton buildings with Willett Hoffmann and Assoc. as we prepare budgets for demo of the out buildings.

Held an Ad Hoc meeting for the Ogle County Economic Development Corporation. Worked on an RFP for an Executive Director search service as well as reviewing staffing and other equipment needs for the position.

Held the kickoff meeting with GOVHr for review and assessment of pay and benefits for several staff positions. The process will take several months and I expect to have a report for Council in late August or early September with recommendations.

Held a meeting with Chief Brooks and his command staff to discuss several possible events in Oregon as well as getting a good assessment of the Police Department's needs and activity this year so far.

Mayor Williams, Council Member Schuster and I met with a local business to discuss tourism strategies. Several great ideas came out of the meeting and I am working through them now.

I met with a business owner to review parking concerns for the downtown and 3rd Street municipal lots. Great discussion which I will follow up with Bill to see if some things can be completed soon and what can be considered for the future.

Finished some research and recommendations for the required municipal code changes due to the change in form of government. Cheryl is working to finish the final changes this week.

Mayor Williams and I have staff meetings set to discuss the change in form of government and to answer any questions. We are working to make the change seamless and smooth.

I fielded a few citizen complaints and are working with the appropriate departments to have these issues addressed. I am always thankful when a citizen expresses their concerns so we can address any issues.

I attended a Webinar on 1st Amendment Auditors with Chief Brooks and Deputy Chief Kalnins. We have had an auditor stop in City Hall in the past. The Audit never hit social media and I feel we successfully provided his requests and followed the law. It is important to make sure we have everything in place legally if we are audited.

The EV Stations are still a work in progress. Public Works is going to finish the cement work then the electrician can come install the new power source. PW is finalizing the egress deck at the Coliseum. CMAAA is hoping to open in June.
