## <u>Submitted by Darin DeHaan - City Manager:</u>

- We are finishing up the pay/benefit review process with GovHR. I hope to have the analysis completed by August 1.
- I attended a Illinois Broadband webinar as we continue to strive toward our goal of becoming a Gig City.
- I completed the work on the new Mural ordinance as well as the grant application process for the ARPA grants.
- Cheryl and I have been working on a variance for a local business.
- Chief Brooks and I received a letter of resignation for Sgt. Josh Lee who has accepted a position with the Ogle County Sheriff's Dept. Josh was an exemplary employee over the last four years and will be missed. We wish him luck with his new position and I know he will become an integral part of the Ogle County team.
- We continue to work on the Sarah Phelps Plaza project. The exterior furniture has been delivered which includes tables and benches. Two of the benches will be donated by the Lions Club and Rotary. The following things remain to be done.

  - Seal coating
  - o Dumpster corral fencing
  - Pergolas
  - Landscaping
  - Set Furniture
  - Chain Fencing installed around the plaza.
- I continue to work on the City budget with Council Member Schuster.

- We launched the new tourism micro-grant program for local businesses and nonprofits. I approved the 1st application submitted by the Ganymedes baseball team. Their games are great events for our community. I have had one other inquiry that I am working on.
- DEMO information for the old Dayton Superior Buildings has been promised for the 1st week in August. That remains a work in progress.
- PW is completing final cement work as preparation for the EV Charging equipment. The equipment has been delivered and should be installed soon.
