

**TAX LEVY ORDINANCE NO. 2022-124**

WHEREAS, THE CITY COUNCIL OF THE CITY OF OREGON IN THE COUNTY OF OGLE AND THE STATE OF ILLINOIS DID ON THE 26<sup>th</sup>, DAY OF JULY 2022, HELD A PUBLIC HEARING AND PASSED THE ANNUAL APPROPRIATION ORDINANCE FOR THE CITY FOR THE FISCAL YEAR BEGINNING ON THE 1<sup>st</sup> DAY OF MAY 2022. NOW, THEREFORE,

**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OREGON, ILLINOIS

SECTION 1: THAT THERE BE AND IS HEREBY LEVIED UPON ALL THE TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF SAID CITY SUBJECT TO TAXATION FOR THE YEAR 2022, THE TOTAL SUM OF DOLLARS \$778,437.56 FOR THE FOLLOWING SPECIFIC PURPOSES MENTIONED IN SAID APPROPRIATION BILL AND IN THE RESPECTIVE SUMS AS FOLLOWS:
