Dear Members of the Oregon Planning Commission,

On behalf of the Oregon Fire Protection District, this proposal letter is meant to request and substantiate the grant of a Special Use Permit for 100 W. Washington Street, Oregon, IL. It is the intention of the Oregon Fire Protection District to expand the main station by approximately 9,996 square feet.

When the station was originally built in 1984, it was intended solely to house the volunteer fire department. However, in 2015, the District added EMS services, which has developed a full-time staffing of 9 firefighter paramedics in 2024.

The proposed extension is essential to accommodate the growing needs of our community and enhance the efficiency of our emergency response services. With our transition to full-time staffing and the acquisition of updated equipment, the current facility is no longer adequate to support our operations. The cost of this addition is estimated to be \$4 million, whereas constructing a new station could double this cost. We understand the importance of utilizing taxpayer funds in a responsible and efficient manner. By opting for this extension, we are committed to maximizing the value of every dollar spent, ensuring that we continue to provide exceptional service to our community while being fiscally prudent.

It will be our intention to maintain the green space behind our station, ensuring that the community continues to benefit from this valuable resource.

### NATURE OF THE SPECIAL USE PERMIT:

Permitted Use: Based on the Zoning Ordinance for the Riverfront District Division 3, c) Permitted
Uses (2) we are requesting a variance for Special Use. We will continue to operate as a
Governmental Entity, namely a Fire Protection District offering Paramedic Services.


