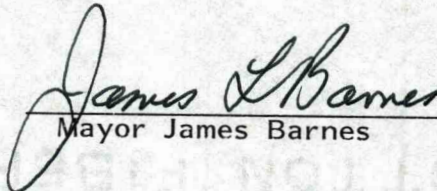
Commissioner Crenshaw moved to reconvene to regular session.

Seconded by Jim Lauer.

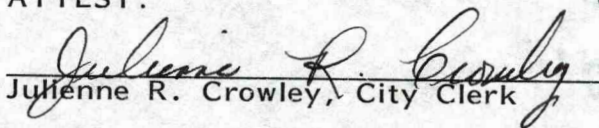
