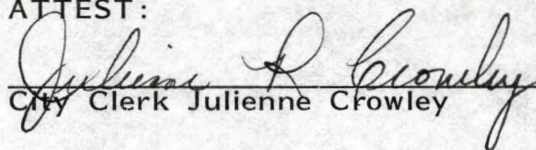
Mayor Barnes acknowledged two certificates from the National Congress that were given to Inez Miller.

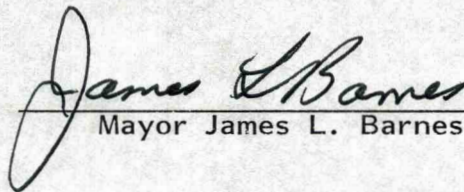
There being no further business, Commissioner Collins moved that the meeting adjourn to reconvene Friday, February 16th at 12:15 P.M., Council Chambers.
