He further moved that the firm be paid an amount not to exceed \$6,200.00 for the performance and upon completion of the audit. Seconded by Norman Collins. Roll Call: Ayes: Collins, Crenshaw, Lauer, Logan, Barnes. No nays. Mayor Barnes moved that the liquor license application submitted by Penny Tobin, D/B/A Penny's Lounge, for a Class A and Class A-1 Liquor License Liquor License for 100 South Second Street, to be effective May 1, 1990, be approved. Seconded by Roger Logan. Roll Call: Ayes: Collins, Crenshaw, Lauer, Logan, Barnes. No nays. Commissioner Collins moved that the City Council approve the Planning Planning Comm Commission recommendation to have the engineer proceed with the preparation Recommendation of a Comprehensive Plan as outlined in their proposal. Seconded by Jim Lauer. Commissioner Crenshaw and Mayor Barnes expressed objections to the cost of the proposal. Roll Call: Ayes: Collins, Lauer, Logan. Nays: Crenshaw, Barnes. Commissioner Lauer moved that the 1990 Street Maintenance Project be 1990 Street awarded to Municipal Maintenance for the amount of \$56,985.66. He further Maint. Project moved that the Mayor and City Clerk be authorized to execute the contract for the City. Seconded by Roger Logan. Roll Call: Ayes: Collins, Crenshaw, Lauer, Logan, Barnes. Appointment Mayor Barnes moved that Joyce Weems be appointed to the Recreation Board with her term to expire June 30, 1991. Rec. Board Seconded by Gail Crenshaw. Roll Call: Ayes: Collins, Crenshaw, Lauer, Logan, Barnes. No nays. Gloria Cronk addressed the Council with a request to start a taxi service Reports in Oregon. The Clerk was instructed to get a sample form and get an application form prepared. Chief Miller asked that the Council prepare an ordinance in accordance with the legislative change on fines and community service. Attorney Smith will prepare the ordinance. Commissioner Lauer corrected a newspaper story which stated that the City would furnish free trees. He explained that the City was trying to get a survey on who would be interested in planting trees in the terrace. After the survey, a proposal will be brought to the Council. Attorney Smith advised that the owners of the property next to the treatment plant had contacted him and they were interested in negotiating on some land. Mayor Barnes acknowledged a certificate of appreciation from Project Play. Vi Myers addressed the Council with a complaint over a water-sewer hook up Citizen fee which she was required to pay in East Oregon and she found that others Complaint had had their fees waived. She felt this was not fair and asked that her fees be returned to her. Mayor Barnes advised that it falls within the Commissioner's jurisdiction to waive the fees if it falls within that department There being no further business, Commissioner Logan moved that the meeting Adjournment be adjourned.
