Commissioner Lauer advised the Council that the downtown sidewalk replacement project has started and they are finding several underground vaults which will have to be filled in and support walls put in. Attorney Smith advised that it is the property owners responsibility to put in the walls. As soon as Commissioner Lauer knows how many there is to be installed and filled in, he will contact the property owners.
