a letter to Cain on this matter.

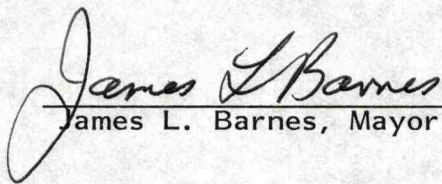
