Commission should set a hearing date for February.

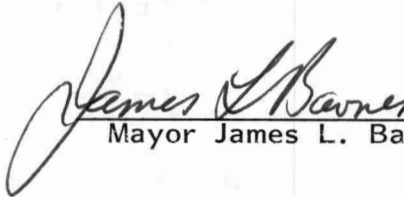
There being no further business, Commissioner Aurand moved that the meeting be adjourned.
