The Council of the City of Oregon met Monday, January 9, 1984 at 7:00 P.M., City Hall building.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Mayor Barnes moved that the application of Gerald Medlar, D/B/A Oregon Bowl, for a license to operate 20 mechanical amusement devices be approved. The fee of \$110.00 is on file with the City Clerk and the term of the license to be January 9, 1984 through April 30, 1984. Seconded by Elma Braden.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Dan Dunlap, owner of Pineway Liquor, addressed the council requesting that consideration for Sunday liquor sales be considered. After discussion,

Mayor Barnes advised Dunlap that the council would review the request.

Gary Heimstead, Vice President and Director of Operation for Rock

Valley Cablevision, addressed the council with a request for an increase in

basic cable service rates, adjustments on extra outlets and the non-pay policy

for cable service.

Commissioner Collins moved that a public hearing covering a request for Rock Valley Cablevision to increase the basic cable service rates from \$8.25 per month to \$9.45 per month effective March 1, 1984, also adjustments on extra outlets and the non-pay policy, be held February 13, 1984 at 7:30 P.M., city hall building. This hearing will be held in compliance with Section 12 of Ordinance #744, Cable Television Franchise. Seconded by Frank Svoboda.

Dennis McMullen, representative of McClure Engineering, gave a report on various city projects.

The council approved the clerk's recommendation to issue a raffle license to Ogle County Homemakers Extension Association.

Commissioner Svoboda advised the council that Walter Janssen and Harry Fletcher would be attending school at Edwardsville for a NPDES Testing course.

Chief Robert Jones gave the annual arrest report.

Mayor Barnes advised the council he had issued a warning to Linda Johnson, owner of Ganymede Lounge, for staying open after closing hours. He had received two police reports of this violation. He is now in receipt of a third report and advised he would issue Johnson a notice to appear for a liquor hearing.

Mayor Barnes advised he was in receipt of a letter from the Illinois
Liquor Commission advising that the Oregon Bowl license application to the
state listed a partnership, of which only one partner was a resident within
the corporate limits of Oregon. This is in violation of the state statute.
The city license was issued to Gerald Medlar, a resident of Oregon. Mayor
Barnes advised that he had talked to the owners and they are in the process
of incorporating and will apply for a new license.

There being no further business, Commissioner Collins moved that the meeting be adjourned. Seconded by Elma Braden.
