Commissioner Tom Izer announced that the first concert in the park and city picnic will be Tuesday June 20th at Park West.

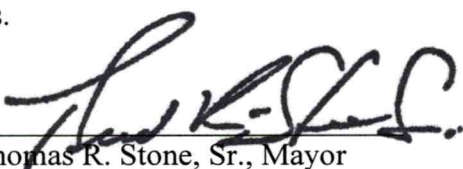
A raffle license for the VFW was brought in today. The council gave the ok. Since it was not on the agenda it will be ratified at the next meeting.

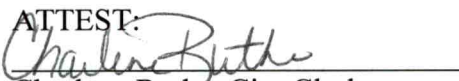
Commissioner Bob Rees handed out a packet of information he has put together regarding the different projects he has been working on with Mike Burris and David Files from CMT.
