The Council of the City of Oregon met in regular session Monday, January 10, 1983 at 5:30 P.M. at the City Hall Building.

Present: James Barnes, Mayor and Commissioners Robert Aurand, Frank Svoboda, James Ludwig and Norman Collins.

Absent: None.

Also present: City Attorney David Smith, Chief of Police Robert Jones and City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Collins moved that the minutes of the December 27, 1982 meeting be approved as recorded. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Ludwig moved that Ordinance #875, an ordinance supplementing and amending the Parking Regulations Code be introduced and filed for public inspection. Seconded by Frank Svoboda.

Dennis McMullen, representative of McClure Engineering, gave a report on several city projects.

The Council approved the Clerk's recommendation to issue the Yellow Bird Senior Citizen Center a raffle license.

There being no further business, Commission Aurand moved that the meeting be adjourned. Seconded by James Ludwig.
