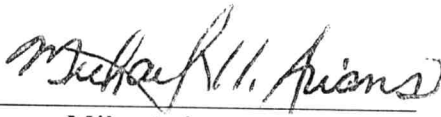
The Mayor thanked the community for their support in the past few months.

Commissioner Jim Lauer moved to adjourn the meeting, Seconded by Commissioner Amy Trimble.

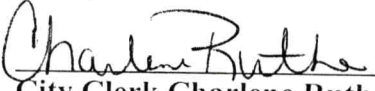
