January 11, 1988 Council Meeting Page 2 Seconded by Norman Collins Roll Call: Ayes: Collins, Crenshaw, Lauer, Logan, Nays: None. Barnes. Commissioner Crenshaw moved that Ord. #950, Ord. 950 an ordinance amending Chapter 2, Article 2, Sec. 2-25. "Rules: Order of Business" be passed. Seconded by Roger Logan. Withdrawn Mayor Barnes questioned Commissioner Crenshaw's intent on proposing this ordinance. Commissioner Crenshaw stated that she felt that anyone could get their message across in that length of time. She stated she felt it was not fair to other people in attendance on other issues to have to be subjected to lengthy performances. Commiss Lauer advised he thought the council followed Roberts Rules of Order and under the debating Commissioner section of Roberts Rules, a person is only allowed ten minutes. Attorney Smith advised that without passing this ordinance, that rule is already in the code. He recommended that when this rule is violated, it is up to the council to call the rule of order. Commissioner Crenshaw withdrew her motion on this Ordinance. Citizen Complaint David Lonsway, owner of the Oregon Bowl, addressed the council with requests and Oregon Bowl clarification of the city code. He asked that the hours of the bowling alley (Sec. 4-278) be extended past midnight as they have Moonlight Bowling and various activities in the bowling alley portion of the building. He also requested the council clarify the portion of the ordinance regarding employees cleaning after closing hours. He advised that his establishment was written up on police reports on November 14th and 22nd, 1987 for being open after hours. He explained that it was his employees in the bar area cleaning. He didn't feel that was a violation of the city code. Attorney Smith advised that the cleaning stated in the ordinance did not include routine cleaning but major projects, like carpet shampooing or repairs or redecorating. The Council will review the ordinance and advise at the next meeting. Commissioner Crenshaw introduced to the Council Student Government the formation of a Student Government Council Council made up of high school students who would come to council meetings to observe proceedings and get a true meaning of governments and perhaps make recommendations to the council. Mike Personaire, principal of the high school, agreed to participate in the selection of students with the government. with the government classes teachers. Th Council agreed such a council would be an The asset and advised Crenshaw to proceed with it. Chief Miller gave the December police activity Reports report. Commissioner Lauer advised that he had a request from John Kerr, 605 S. 5th, who had received two snow parking tickets because he had moved his car from one side of the street to the other, thinking he was assisting the street department in their plowing, but he was parked on the wrong side of the street on the wrong days. The Council agreed the tickets would have to stand as written.

Commissioner Lauer suggested to the Council that Mix Park be flooded and froze over for an ice skating rink. The Council agreed.
