The Council discussed the petitions submitted for tax abatement. The Clerk is to check with the County Clerk to see what is necessary to abate the taxes. The petitions were from F. N. Smith Company and Washington Corners.

Commissioner Crenshaw moved to add monies in the amount not to exceed \$32,000 to the already approved \$150,000 for the Wastewater Treatment Plan Rehabilitation Plan and to direct the City Clerk to instruct McClure Engeering to contact EPA by the end of this week to complete necessary work to obtain the permit. Seconded by Norman Collins.

Mayor Barnes asked that the Council consider amending the liquor ordinance to eliminate gas stations from package liquor licenses. The Council agreed. Attorney Smith was instructed to draw up an ordinance for the next meeting.
