Mayor Tom Stone announced that the trip to Washington D.C. last week will hopefully lead to federal money to help fund upgrading the wastewater treatment plant. The city is requesting between \$1-2 million for the project. The meetings with the Senators and Congressman were arranged by Robin Johnson an EMC lobbyist.
