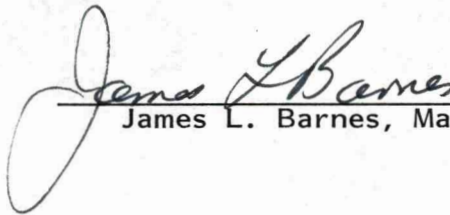
Mayor Barnes advised that the recreation Board, himself and the Park District will be meeting again February 5, 1991 to discuss the city pool.

Seconded by Gail Crenshaw.

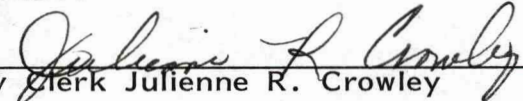
