Chief Miller gave a year end report on police activities.

Commissioner Aurand advised the Council he was in favor of the City participating with the Sheriff's Department to purchase the FATS machine for training. The cost would be \$2,500.00 per year for five years. Aurand asked Chief Miller to check to see which periodicals he could eliminate to help cover the cost.

Attorney Smith advised that the Deed of Dedication for the four Terrace View lots was ready. Commissioner Aurand will present the deed to the Oregon Park District at their Tuesday night meeting.

There being no further business, Commissioner Aurand moved to adjourn. Seconded by John Priller.
