The Council of the City of Oregon met Monday, October 10, 1983 at 7:00 P.M., City Hall building.

Present: James Barnes, Mayor and Commissioners Elma Braden, James Ludwig and Frank Svoboda. Absent: Norman Collins.

Also present: City Attorney David Smith, Chief of Police Robert Jones and City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved that the minutes of the September 26, 1983 meeting be approved as recorded. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Braden, Ludwig, Svoboda, Barnes. No nays.

Said motion carried on roll call as follows: Ayes: Braden, Ludwig, Svoboda, Barnes. No nays.

Mayor Barnes moved that the application of Feeder Lot, Inc. for a Class A liquor license be approved, that the lease, surety bond and fee of \$350.00 for the period October 11, 1983 through April 30, 1984 be approved and a license be issued. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Braden, Ludwig, Svoboda, Barnes. No nays.

Commissioner Braden moved that the council meetings during the winter months, beginning November 14, 1983 through February 20, 1984, be changed to 5:30 P.M. Seconded by Frank Svoboda.

Said motion on roll call: Ayes: Braden. Nays: Ludwig, Svoboda, Barnes. Motion did not carry.

Mayor Barnes proclaimed October 15th Lions Club Candy Day and October 26th Illinois Employee Fitness Day.

Several citizens addressed the council objecting to having no parking during school hours signs put up on Madison Street between Ninth and Tenth Streets, also objecting to the school students who park along the street during school hours. After discussion, Mayor Barnes advised them to attend a school board meeting and request that they enforce the rule that students are to park in the school parking lot. He advised if they did not get satisfaction from the meeting, to return to the council.

Dean Johnson addressed the council requesting a variance to hook onto a private water line at Second and Clay Streets. He is interested in the Etnyre building but there is no water connection there. He wants to hook onto Larry Wright's private line. The council suggested he contact the other property owners on private lines in that area to see if they would be

interested in having the city put in a line then assessing each property owner for the expense. Engineer Dennis McMullen was instructed to check into the cost of installing a line and will report back to the council. The council discussed issuing Johnson a temporary permit to connect to Wright's line.

The council approved the clerk's recommendation to issue Oregon Booster Club a raffle license.

The council set Halloween hours for Monday, October 31st. from 6:00 P.M. to 9:00 P.M. Chief Jones suggested the youngsters be advised to only visit houses with porch lights on.

Commissioner Ludwig approved a driveway permit for the Oregon Fire Department contingent upon the state's approval for their new location at Route #64 and First Street.

Commissioner Svoboda recommended to the council that since the fire department is building a new building and will be vacating city hall, to let them continue using the city hall building at no charge for six months, then review the progress of the construction and determine at that time if rent should be paid. The council approved the recommendation.

Commissioner Braden presented the fire department building permit application to the council. After review, the council approved the application.

Mayor Barnes moved the clerk be directed to publish notice of the city's intent to seek exemption under HB203 from Mandatory Chlorination for the city's public water supply. Public hearing to be held October 24, 1983 at 7:30 P.M. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Braden, Ludwig, Svoboda, Barnes. No nays.

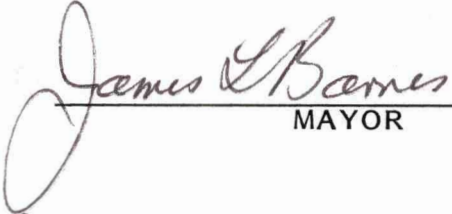
