- The 10" water main was installed by this property on May 25, 1982.
- 2. The street paving was completed by this property on June 16, 1982.
- Test indicate there are no leaks in the 10" water main.
- 4. Excavation in terrace in front of property indicate no shifting of natural soil conditions.

Based on the above items, I can $\underline{\text{Not}}$ see any relation between our water main project causing the foundation collapse at the Lovvorn property.
