Mayor Barnes advised he had received another letter from the Anti-Defamation League requesting a response to their previous letter. Attorney Smith advised not to respond. The Council agreed.

Mayor Barnes proclaimed October National Lupus Awareness Month and Knights of Columbus "Mentally Retarded Program" days.

7:15 P.M. - A Public Hearing was held on the Tax Levy increase which is required under the Truth in Taxation Act. There were no comments or questions from the audience.

Kay Karhatsu, President of the Oregon VFW Auxiliary, presented Chief Miller with a check for \$50.00 to buy teddy bears for abused children.

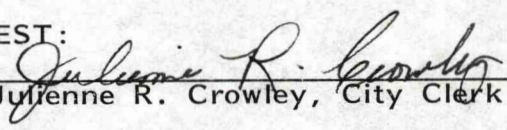
There being no further business, Commissioner Lauer moved that the meeting be adjourned.

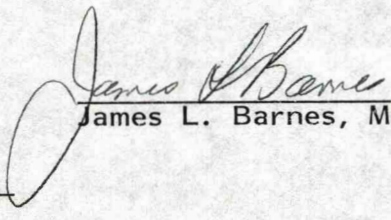
