Commissioner Svoboda asked what the Council is going to do about the sewer problem on Tenth Street of Jim Laughlin's. The attorney advised that if this is on his own property, it is legal to repair it according to our code. If the break was on City property it would not be legal.

Chief Miller advised that trick or treat hours will be Sunday from 4 - 8 P.M.

Attorney Smith advised that the Oregon Park District has submitted a petition to annex 22.6 acres to the City at Oregon Park East. This will be put on the agenda for the next meeting.

Attorney Smith advised he had a call from Ron Bry, owner of the old Blackhawk Hotel on North Third Street. Bry indicated that they had a survey done and it doesn't indicate that there are as many parking places available as was originally thought and he won't be able to lease spaces to Brewer for his apartments.

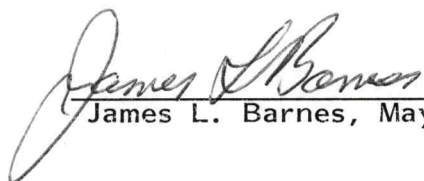
