Engineer's Report:

Engineer's Report

1. Reported that Franklin Street is complete and the State will check it next week. There were objections to the intersection of Sixth & Franklin. On Sixth Street, there is quite a dip on both the north and south end of the intersection. McMullen explained that the rise is too high on the north side of Sixth at Franklin and the situation would correct itself with wear and when Sixth Street is rebuilt.

2. Miscellaneous Water Sewer Projects: Fifth and Seventh Street lines are being tested now. The restoration of properties would be done in the Spring. On Mix Street it is recommended to put some blacktop on the street, enough to get through the Winter. Mix Street Sewer Line - a letter to be written to Dave Martin advising that if he is going to develop his property, an EPA permit will be required to extend the line, also a plat will have to be submitted for the Plan Commission's approval before starting with the development.

3. Robert Aurand property at Seventh & Route #2: It was not necessary to go through his property but they had already sawed the driveway. The engineer advised that the city would put mastic seal in the cracks for now and would seal coat it next year.

4. Church of God steps on Franklin Street: McMullen will check with them on the location and if it is necessary to use city property, the Department of Transportation will have to approve the site. They are proposing to go down the hill on the southeast corner.

The Council discussed water hook on fees for the new water lines. They agreed that there would be no hook up fees if residents hooked onto the line before June 1, 1987. The old private lines will also have to be properly abandoned.

Commissioner Ludwig advised that he got an estimate of \$5,000.00 to trim and cable trees in the city. He suggested doing this over a two year period. This will be discussed more at the next meeting.

Commissioner Report

The Council discussed raising the Mayor, Attorney and Council fees for the next council period. Figures suggested were: Mayor, \$4,500.00 annually; Council, \$1,800.00 annually; Attorney, \$2,700.00 annually and hourly rate of \$50.00. This will be discussed at the next meeting.

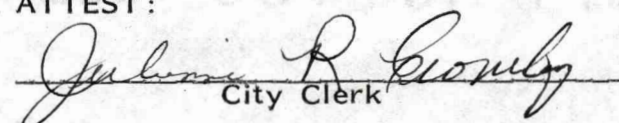
There being no further business Commissioner Collins moved that the meeting be adjourned.
Seconded by Elma Braden.

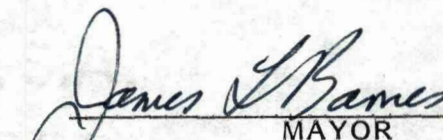
