The clerk announced that petitions for the up coming city election will be available starting Monday, November 15th. Filing dates are December 6th through the 11th.

Commissioner Ludwig had a request for a street light at Conover Square. The clerk is to contact Commonwealth Edison representative Joel McKeel about installing the light on the east side of Third Street in front of Conover Square.

The council agreed to have the clerk contact Vaughn Duck of Rockford Data Systems in regard to the city entering into a contract for a computer system as per their August 5, 1982 proposal. Detailed information will be available for the November 22nd meeting.
