Mark Painter, representative of Beling Engineering, explained some problems on the First Street Reconstruction Project. The project will cost about \$30,000.00 more than estimated. Painter explained that using the traffic factors furnished by the state for the street and the soil tests that were taken, they are coming up with a very thick pavement structure for that street. They had initially estimated a 3 inch asphalt pavement over 10 inches of rock which produced the preliminary cost estimate of \$200,000.00.

Since then with the poor soil conditions that we have, calculations yield a pavement that is 3 inches of asphalt over 17 inches of rock. The additional excavation and rock accounts for about \$27,000.00 of the extra cost. This design is not with curb and gutter but would have to have a two foot ditch on each side of the road for drainage to meet state requirements. The ditch could be a problem for the property owners. A letter will be written by Commissioner Priller to notify the property owners of a meeting where the project will be explained to them.

Attorney Smith asked the Council if they wanted to retain the attorney for assistance on the Cablevision Certification Authority.

Mayor Barnes moved to authorize the Mayor to sign an agreement for legal service with Zukowski, Rogers, Flood and McArdle for assistance on Cable Certification Authority and to pay the retainer of \$1,000.00. Seconded by Robert Aurand.
