John Priller presented to the Council the names and addresses along with a map and type of trees that were planted on the terraces this month. He expressed a desire to have another tree planting in the spring.

The Council approved the raffle license recommendation for St. Mary's Church.

Tim Nieman addressed the Council with a complaint about the noise of the street sweeper and the hours it is operated. He would like the street department to change the hours from 3:00 A.M. or 4:00 A.M. to a more reasonable hour.

The Clerk asked the Council to consider raising the water sewer deposit for residential rental property from \$20.00 to \$50.00.

The Council briefly discussed the skateboard ordinance.

Commissioner Crenshaw advised that she has had a lot of input from residents recently and there is a concern on when the Council is going to fill the vacancy and when she is going to get her department back.

Commissioner Crenshaw moved to direct Attorney Smith to draw up an ordinance to return Water-Sewer Department, Treatment Plant and Coliseum back to Public Property. Seconded by Mayor Barnes.

Commissioner Collins moved to approve an ordinance to amend the use district and zoning map for property on Seventh and Franklin Streets owned by the Oregon Bible College. Seconded by Gail Crenshaw.

Mayor Barnes presented a letter he received complimenting Chief Miller.

Mayor Barnes advised that he and Harry Fletcher had attended a presentation on reading meters sponsored by N-I Gas Company and advised that he feels that the City can save some money if the gas company reads the water meters.

Mayor Barnes advised that he had a request for four or five handicapped parking spaces by the Catholic Church. Commissioner Lauer will check on this.

There being no further business, Commissioner Lauer moved that the meeting be adjourned. Seconded by Norman Collins.
