Commissioner Aurand moved to authorize the Mayor and Chief Miller to negotiate a contract with Attorney Dennis Schumacher to handle the prosecution of city police cases. Seconded by Gerald Medlar.

Gary Eckhardt, representing the Oregon Chamber of Commerce, requested that Dawson Subscription Service receive tax abatement under Ordinance No. 957. They asked for the maximum abatement. The Council approved the request and will have a resolution at the next meeting.

Russ Barton, representative of Northern Illinois Gas Company, spoke to the Council in regard to the gas company franchise renewal. There were several items the Council would like to have considered in the renewal. Barton will meet with representatives of the Council to discuss this.

A Public Hearing was held at 5:45 P.M. in regard to Ordinance No. 1063, an ordinance seeking chlorine exemption. There were no comments from the audience.

Mayor Barnes moved that Ordinance #1063, Seeking Chlorination Exemption, be passed. Seconded by John Priller.

Bob Burke addressed the Council with a request to lower the speed limit to 20 mph on Fourteenth Street due to the increase of activities at Oregon Park West. He stated there is much more traffic and there are a lot of children on that street. In the future, he would like to see a different access road developed to eliminate the access to the park from Fourteenth Street. Commissioner Priller will look into this.

Commissioner Priller advised he wants to take some action on the Burning Ordinance drawn up by Attorney Smith. This will be on the agenda for discussion at the next meeting.

Commissioner Aurand advised that a few weeks ago the Council agreed to turn over the four lots in the Williams Subdivision to the Park District for a park and he asked for the Council's view point of turning over the other three parks that the City has to the Park District. He explained the different situations with each park. Aurand and Attorney Smith has gone over each of the parks and their certain situations and will have proposed leases and agreements for each park soon.
