No nays. issued to the Ogle County Housing Authority on July 27, 1981 to build five two-family dwellings on Lots 1 and 8 on the plat of Terrace View Subdivision No. 2 be rescinded upon dismissal of

Commissioner Svoboda moved that the Special Use Permit the case - Terrace View Residents vs. Ogle County Housing Authority and City of Oregon. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig. Nays: Collins, Barnes.

George Trampel addressed the council in regard to a solution to his garage being on one foot of city property. Mr. Trampel agreed to sign a statement acknowledging the overlap and agreed to move the garage upon 60 days notice if he has to. The council decided to wait until after the first of the year to make a decision on whether the garage would have to be moved and instructed Attorney Smith to prepare a statement to be signed by Trampel in regard to the agreement.

Water-Sewer Supt. Jake Ulferts addressed the council in regard to the change in the excavation bond amount. After discussion, Commissioner Collins, with council approval, instructed Ulferts to use his discretion on the amount of bond charged per request on the work to be done and to make the amount between \$50.00 and \$500.00 per bond. This directive is to be effective until the ordinance is amended.

The council approved to raise the price of a main tap from \$6.00 to \$75.00 per tap.

Commissioner Collins advised the council he had inspected the utilities at Sauer's Garage, corner of Second Street and Washington with Supt. Ulferts. The owner is installing a chemical toilet and will use water only as needed in his auto body repair shop so the water was turned on.

Mayor Barnes reported to the council that during the Antique Show at the Coliseum over the weekend, many of the exhibitors drove onto the lawn and left ruts in it. The council instructed the clerk to write to the Coliseum Board expressing their concern about the treatment of the lawn.

Commissioner Ludwig advised the council he would like to hire Dave Doherty full time. The council agreed, his wages set at \$5.00 per hour with a review and possible increase April 1, 1982.
