I believe you are aware of the fact that on Friday, October 5, of this year, that when Dodson Plumbing was doing some excavating inside the curb at the corner of 6th and Madison Street in regards to installing a new water line for the addition to the Nash Recreation Center and caping and abandoning the current service to Nash that they broke a valve on the existing three inch water main that serviced Nash School.

The problem that developed from that situation in the form of the inability to locate the necessary valves to shut off the service to that three inch main cost Dodson some considerable amount of extra labor costs which they have requested the Oregon Park District reimburse them for in the amount of \$1,158.74 above their contract for work on the Nash Recreation Center addition.

The Board of Commissioners at their November 11 Board meeting voted to approve paying the extra compensation, but also request that the City of Oregon consider reimbursing the Park District for part of that cost because of the excessive time taken to turn off the water main so that the plumber could make the necessary repairs to the broken valve.

Enclosed you will find a copy of the letter from Dodson Plumbing showing a break down of the labor and material costs regarding this situation.
