Chief Miller advised the Council he would like to initiate
a Physical Fitness Program for his department. He would
like for the officers to have an annual physical, paid for
by the city, and have the officers pass a fitness test which
would be set up by himself. He would like to have it start
January 1, 1987 and have the test in six months. Commissioner
Collins advised he would prefer to study this request and
discuss it at the next meeting.

Reports

Chief Miller gave the November activity report.

Commissioner Braden advised that there are many junk
cars around the city that the owners cannot move because
the titles are held by finance companies. Attorney Smith
advised the city could contact the finance companies,
advise them of the situation and ask for their cooperation
to comply with the city code.

Several citizens protested the rate increase for cable
television and requested the city to file a protest against
it. Mayor Barnes explained that as of January 1, 1987 the
city has no control over the rates as the deregulation
law goes into effect. The city, however, will file a protest.

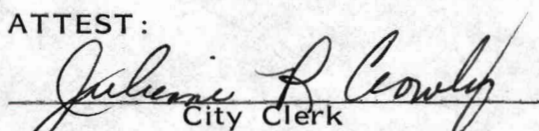
There being no further business, Commissioner Collins

Seconded by Elma Braden.

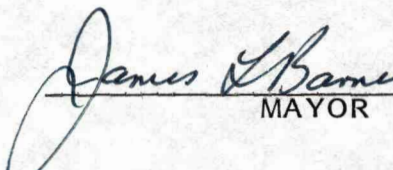
Adjournment
