Mayor Barnes moved that the City of Oregon departments observe the following legal holidays for 1992.

January 1, 1992, New Year's Day; January 20, 1992, Martin Luther King's Birthday; February 17, 1992, Presidents Day; April 17, 1992, Good Friday; May 25, 1992, Memorial Day; July 3, 1992, Independence Day; September 7, 1992, Labor Day; October 12, 1992, Columbus Day; November 11, 1992, Veterans Day; November 26, 1992, Thanksgiving Day; November 27, 1992, Day After thanksgiving; December 25, 1992, Christmas Day.

Mayor Barnes moved that the Police Department be instructed not to police the parking meters from December 10, 1991 through December 26, 1991. He further moved that the money collected from the parking meters during that period be given to Oregon Service Clubs toward food baskets for needy families.

Seconded by John Priller.

Roll Call: Ayes: Aurand, Medlar, Priller, Svoboda, Barnes. No nays.

Commissioner Svoboda advised the Council that Dave Kitzmiller has passed his Class C Water License. Roger Warrenfeltz suggested that Kitzmiller be compensated for his achievement with a \$100.00 per month salary increase. The Council congratulated Dave on his achievement but advised that this was taken into consideration when the annual salary schedule was made and that he got a substantial raise at that time.

Commissioner Priller advised that he was considering some engineering work on Mix Street, from Monroe to Scott, due to some water problems. The way the water is draining off of Monroe Street through the intersection along with the water coming down Mix Street from above Monroe Street, it is not being all caught in the catch basin at the corner of Monroe & Mix. It is creating a problem for the property owners on the east side, south of Monroe on Mix Street. He advised he had talked to a representative of Willett, Hofmann Engineers and they talked about putting a curb on each side of the street, widening the street to 35 feet and it would be in line so that any further work that would be done on Mix it could be continued on from any existing work that might be done. The estimated cost for engineering would be just from Monroe to Scott, \$5,000; from Monroe to Washington, \$8,000; project cost estimate from Monroe to Scott, \$20,000; Monroe to Washington, \$105,000 - \$115,000.

Jerry McClain complained about the two catch basins in the private alley north of Washington Corner being sunken and covered with solid covers not allowing the water to drain into the sewer and causing ice to form which is dangerous. Attorney Smith is to check to see what the City can do about this situation since it is a private alley.

There being no further business, Commissioner Aurand moved to adjourn Seconded by Gerald Medlar.
