Mayor Barnes moved to reconvene to regular session. Seconded by Roger Logan.

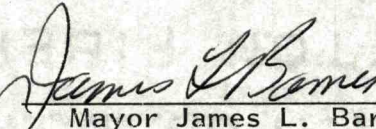

Commissioner Crenshaw moved that the meeting be adjourned. Seconded by Roger Logan.

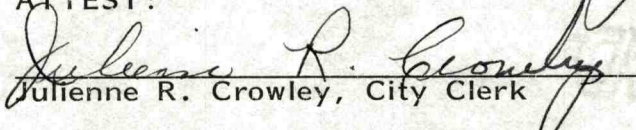
