A Public Hearing was held on the Tax Levy Ordinance in compliance with the Truth In Taxation Act. Commissioner Aurand answered the questions of Moe Kielsmeier in regard to the Levy.

Commissioner Aurand moved that Ordinance #1044 - Tax Levy - be passed.

Commissioner Priller advised that he had met with the property owners and representatives of owners on the First Street Reconstruction Project. The engineer is getting cost estimates for curb and gutter or alternatives to the present proposed plan.

Commissioner Priller advised that the City will be having a tree program again for spring. A notice has been put in the paper with types of suitable trees and deadline dates.

Mayor Barnes advised that the City has petitioned for a rehearing in the Alfano liquor appeal case. It will be set for January.

There being no further business, Commissioner Aurand moved that the meeting be adjourned.

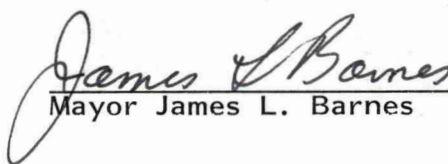
