Commissioner Lauer moved that Ordinance #984, introduced and filed for public inspection on December 11, 1989, be passed. Seconded by Roger Logan.

Commissioner Lauer moved that Ordinance #985, introduced and filed for public inspection on December 11, 1989, be passed. Seconded by Roger Logan.

The Council questioned the wording of fencing and boards around excavation and agreed that it should be reworded to barricades. After minor changes in the wording of the Ordinance, roll call was taken.

The Council discussed the agreement submitted to Commissioner Collins by Moring Disposal in regard to Solid Waste Disposal and Residential Curbside Recycling. Attorney Smith advised that he had talked to Commissioner Collins earlier in the week and advised him that there was no way he could have ordinances ready by this council meeting. He advised that by the next meeting the ordinances could be ready. Larry Moring explained that their main interest right now is to get a commitment on curbside recycling so that he can order the containers, which will take approximately 90 days to get,

Mayor Barnes moved that the City express to Moring Disposal, Inc. the City's willingness to negotiate an agreement for curbside recycling in the City of Oregon.

Seconded by Gail Crenshaw.

Commissioner Logan submitted a memo to the Council in regard to Employee Group Insurance, explaining that the City has absorbed all premium increases since 1983 and the employee share has gone from 13% to 7-8% over the years. He advised that he feels the employee share should be increased to the 13% which it was up until 1983.

Commissioner Logan moved that the employee contribution for group insurance be increased to \$18.85 for single coverage and \$45.50 monthly for family coverage effective January 1, 1990.

There being no further business, Mayor Barnes moved that the meeting be adjourned.
