Arnie Risley , EMC, gave an operations report on the water and wastewater facilities.

Jim Grove, Oregon Park District, explained to the Council what the park district wants to do for improvements at Mix Park.

Commissioner Suneson advised that Oregon Township is going to resurface North Daysville Road and the cost to do the city's portion from Mix Lane to Rt. 64 would be \$13,000000. Suneson is to advise the city would like seperate bids for the city portion.

Mayor Barnes advised that Christmas tree pick up will be January 8th & 22nd.

Mayor Barnes advised he received a request from the Chamber of Commerce that the city resume the responsibility of putting up the flags and banners.

Commissoner Medlar moved that the city decline the request. Seconded by Ted Suneson

Mayor Barnes advised he had received a letter from Ill. Dept. of Transportation in regard to the reconstruction of the Rt. 64 bridge and the lighting. The Council agreed to go with the 2nd option, which is 12 light poles, six each side, 40 feet in height, utilizing 250 watt HPS luminaires spaced 200 feet apart costing \$3,350 each for a total of \$40,200. Mayor Barnes would also like conduit along the sidewalk for future decorative poles.

Wilbert Schultz advised the Council that he and Tom Early need to get off the private sewer line and asked whose responsibility is was to put the line to the main. The Council advised it was their responsibility.

There being no further business, Commission Aurand moved to adjourn.
