A discussion was held on the Plan Commission recommendation for the Bed & Breakfast establishment and Tea Room to be located at 400 N. 3rd Street. Mayor Barnes advised that he had received letters from all but one of the adjoining property owners objecting to the special use permit being issued. According to regulations, Commissioner Logan advised that there had been a procedural error in time limits on the public notice so the recommendation would not be valid on these issues. If no action is taken within two meetings after the Plan Commission recommendation, the issues would be the same as denied. The Council chose not to act on the motions.

Recommendations

Commissioner Logan advised that the council still had sufficient time to put an advisory referendum on the primary ballot asking the citizens of Oregon if they would like the City of Oregon to pass an ordinance permitting bed and breakfast establishments in R1 and R2 residential districts and let the voters in the city decide. The resolution has to be passed by January 10, 1988 and certified to the county clerk by January 14, 1988. Attorney Smith was asked to draw up the resolution at this time.

Reports

Commissioner Lauer thanked everyone who helped the street department on the snow removal.

Mayor Barnes presented the council a letter from the Army Corp of Engineers in regard to Lake Mistake advising that the city could submit an application and the Federal Government would pay for the initial study and then if there is more feasibility then it is drawn up to where the city and federal government share the financial responsibility. If the city feels they cannot afford the cost, then the city can withdraw. The Council agreed to have Attorney Smith complete the application and submit it.

Commissioner Logan moved that Resolution #485, a resolution to place an advisory referendum on the March 15, 1988 primary election ballot be approved. Seconded by Norman Collins.

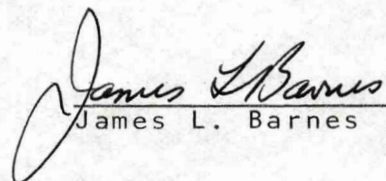

Commissioner Collins moved that the meeting be adjourned. Seconded by Roger Logan.

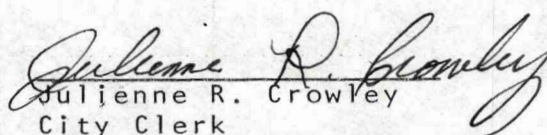
