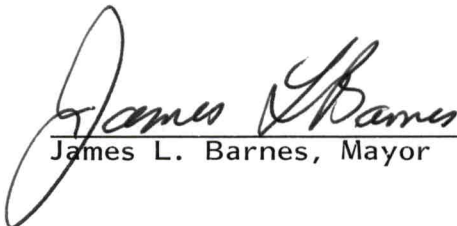
Donna Mann advised there will be a Project Oregon dinner meeting at Stronghold on March 16th to give the results of the consumer survey.
