Mr. Goff stated that his company has installed such a system on three previous occasions.

I am certainly aware and appreciative of the Revenue Sharing Funds the City of Oregon has donated to the Village for the past several years and accordingly will understand if you and/or the City Council determine that we should pay for the repairs. In any event, I would appreciate hearing from you regarding the decision.
