been trimming trees on the terraces.

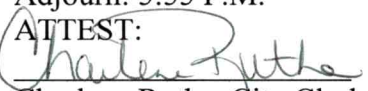
Mayor Tom Stone has appointed a Historic Preservation Commission consisting of
