The Council agreed to ask Francis Reichenbach to check both pianos and advise the Council which would be the best to have.

Mayor Barnes advised that the Lions Club had purchased new street signs for East Oregon.

Chief Miller advised that Gary Robinson had been ordered by the Judge to have his junk cars cleared out of the area on First Street by Monday, February 22, 1988. If this order is not complied with he will be fined \$20.00 a day until all junk is removed.

Chief Miller asked if the Council would try to do something about the traffic problem on Jefferson Street at the schools. Because of the cul-de-sac there is double traffic in and out of the schools and it is very dangerous and congested.

Commissioner Lauer advised that he would have a preliminary proposal for street projects at the next meeting. He would like to have bids let in April.
