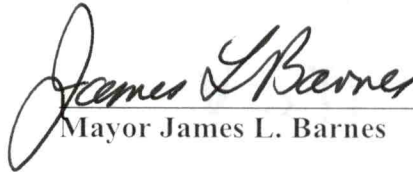
The Mayor is going to form a committee for the census 2000. He reminded everyone how important is to be counted.

2000

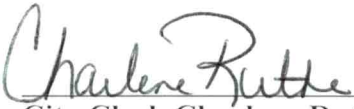
There being no further business Commissioner Suneson moved to adjourn the meeting seconded by Jerry Medlar.
